CHECK LIST FOR STOLEN AND / OR HI-JACKED VEHICLES

In support of your claim, Insurers will call for the following:

- Fully completed claim form
- A copy of the driver's licence, including front page of I.D. document
- A clear copy of the original purchase invoice
- Copies of invoices for any non-standard accessories (not appearing on the original purchase invoice), i.e. truck load-body, LDV canopy, mag wheels, two-way radios, tachograph units, decals, tow bars, bull bars etc.
- Immobilizer certificate and / or itemized purchase invoice
- Complete set of keys and immobilizer control. The spare set in the case of hi-jacked vehicles.
- Where there is a current lease or instalment sale (HP) agreement in force, a letter from the financial institution confirming the outstanding balance on the contract.
- SAP clearance form, completed and stamped by the police station investigating the matter.
- Details of any personal or identifying marks peculiar to the vehicle which may assist in identifying if located.
- Some insurers call for proof of mileage, i.e. a copy of the last petrol card record, last service invoice etc.
