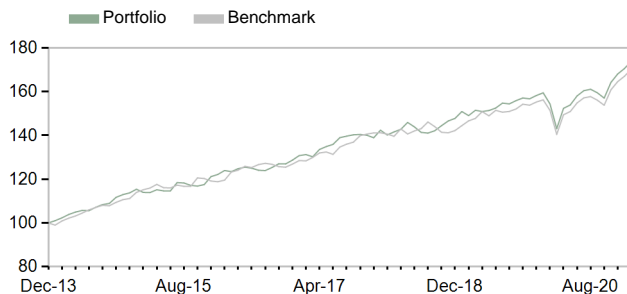

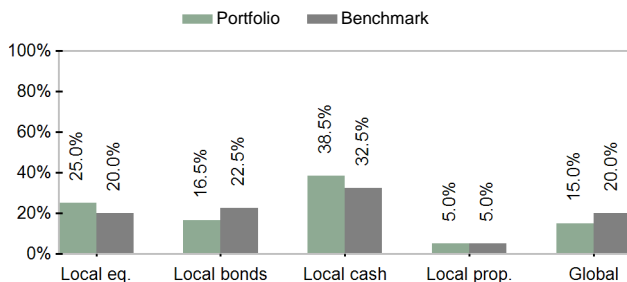

Investment portfolio mandate

This investment portfolio is aimed at achieving capital preservation protected from extreme volatility. The allocation to asset classes is achieved by investing mainly in a combination of passive indices. The portfolio's exposure to bonds and cash will increase in times of uncertainty.

The portfolio is managed in compliance with Prudential Investment Guidelines as well as being comprehensively managed to comply with the limits of Annexure A to Regulation 28 of the Pension Funds Act.
