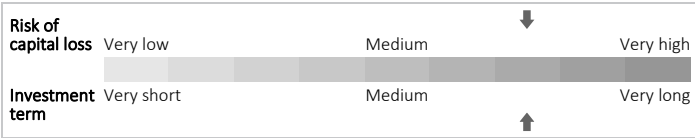
The performance objective of the portfolio is to maximise rand hedge exposure by investing in JSE listed companies that are predominantly hard currency based.

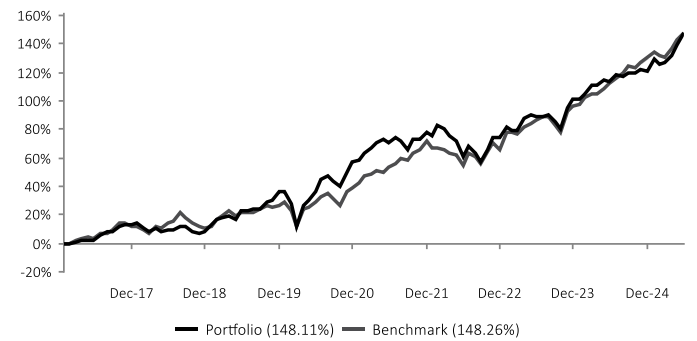

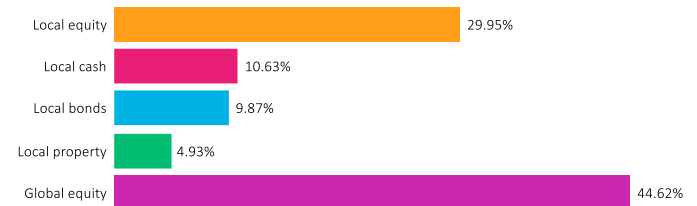
