Investment mandate

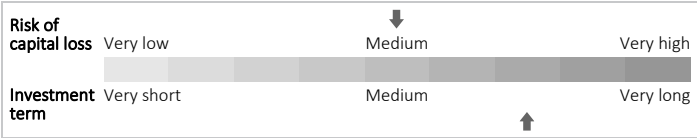

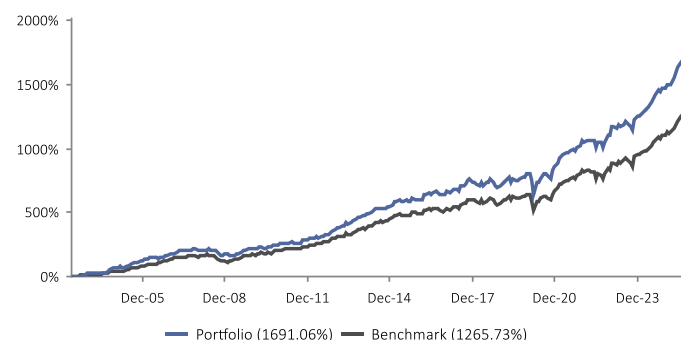

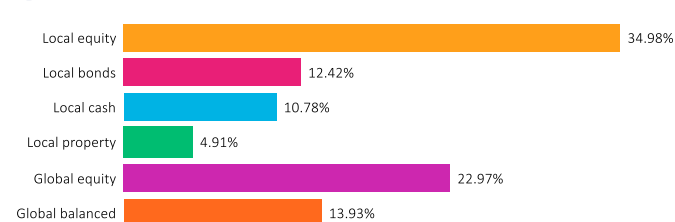
